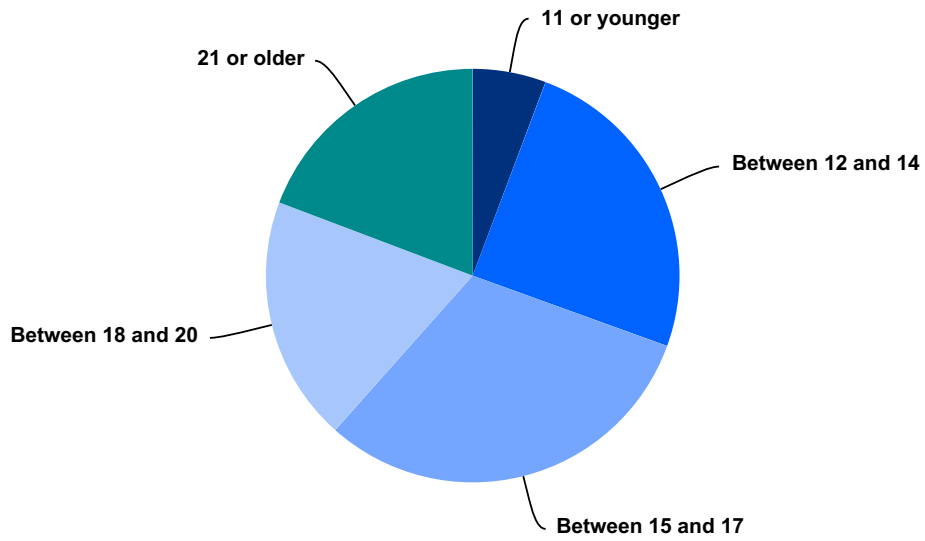

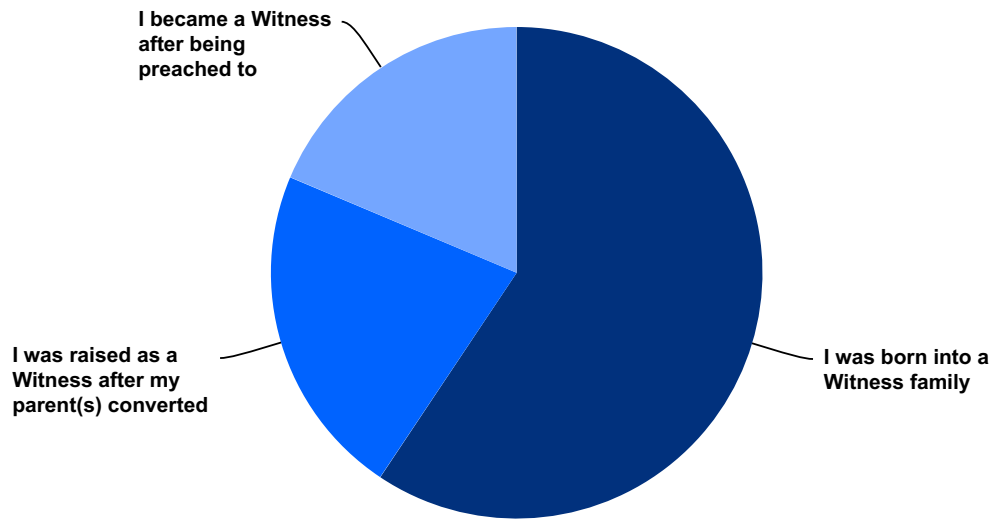

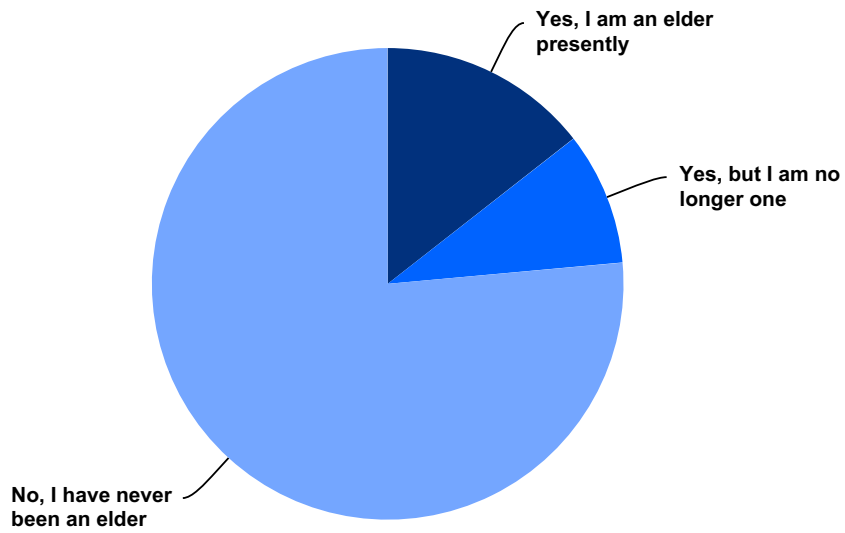

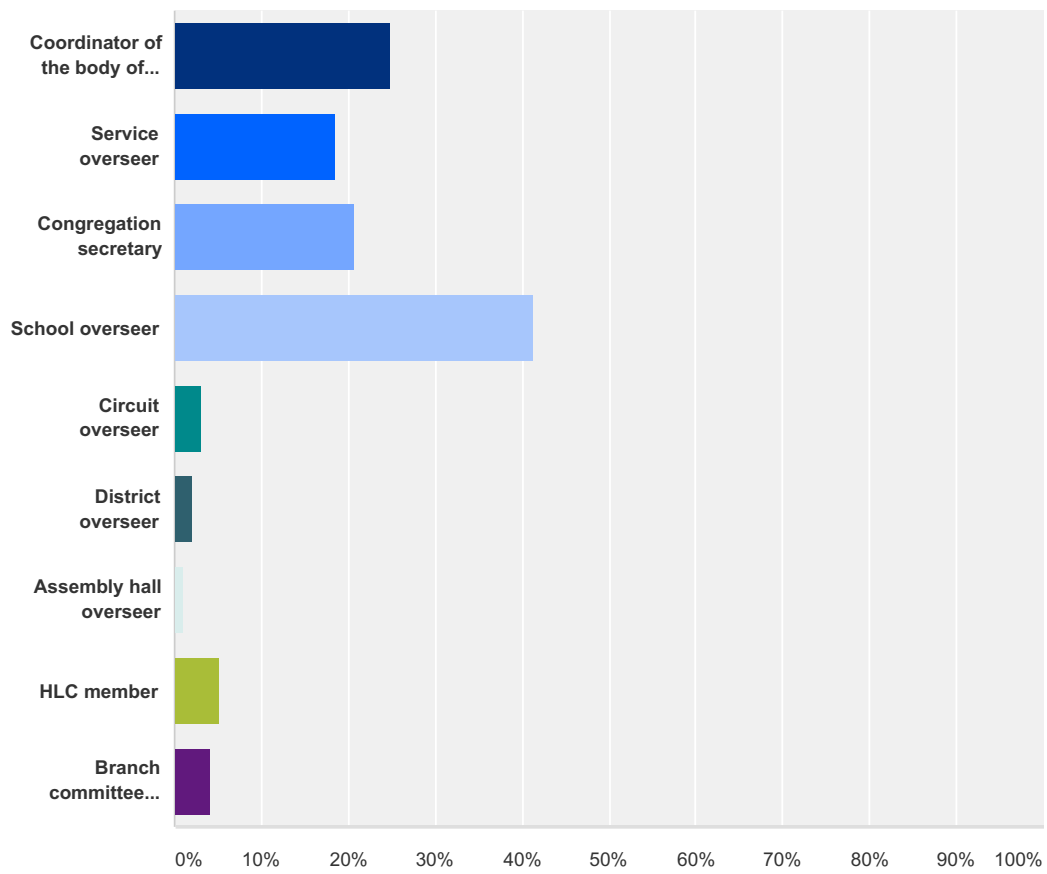

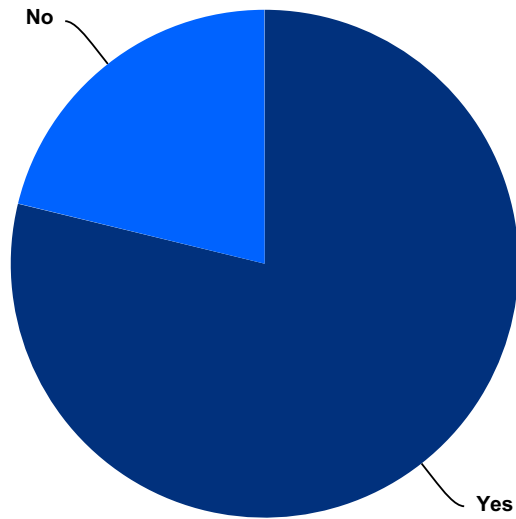

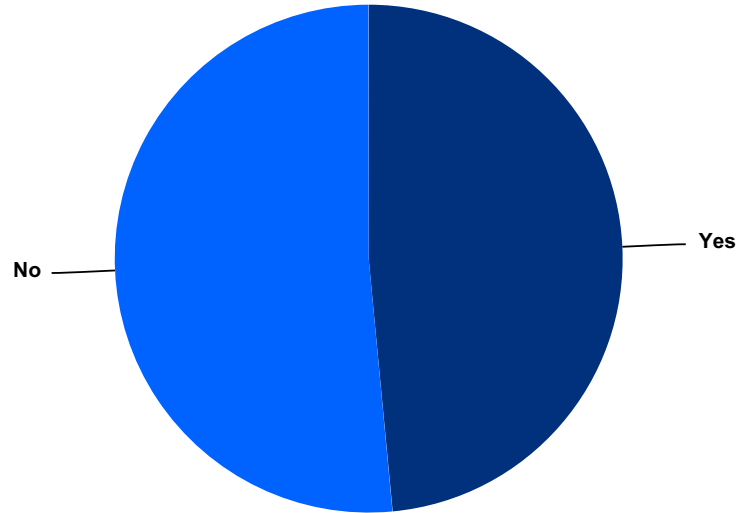

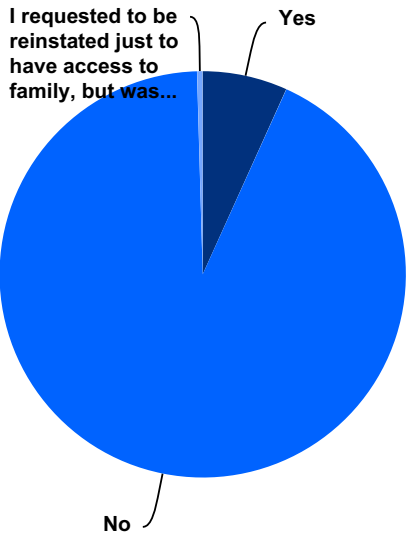

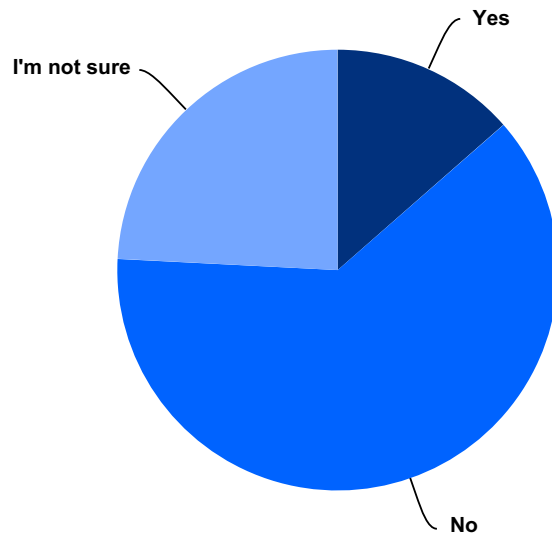

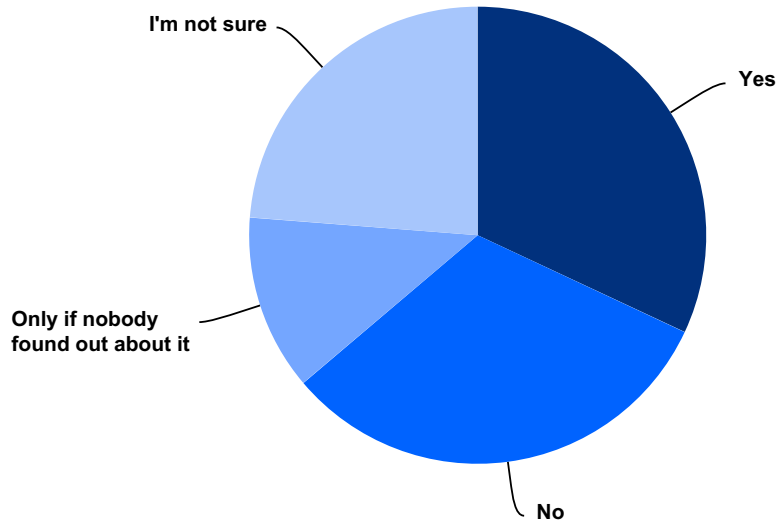

Q43 Would you consider donating blood, even if it was only used for treatment as fractions?

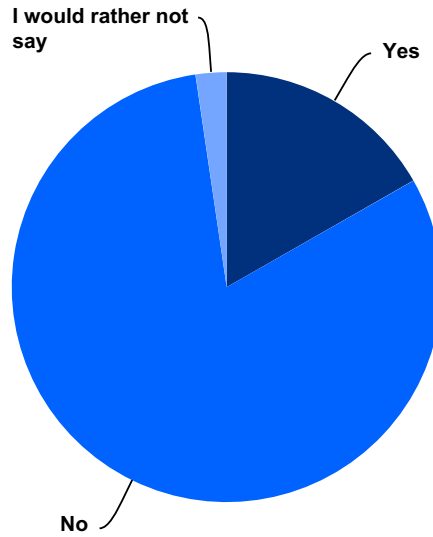

Q44 Do you personally know of a Jehovah's Witness, or child of Witness parents, who died due to refusing blood?

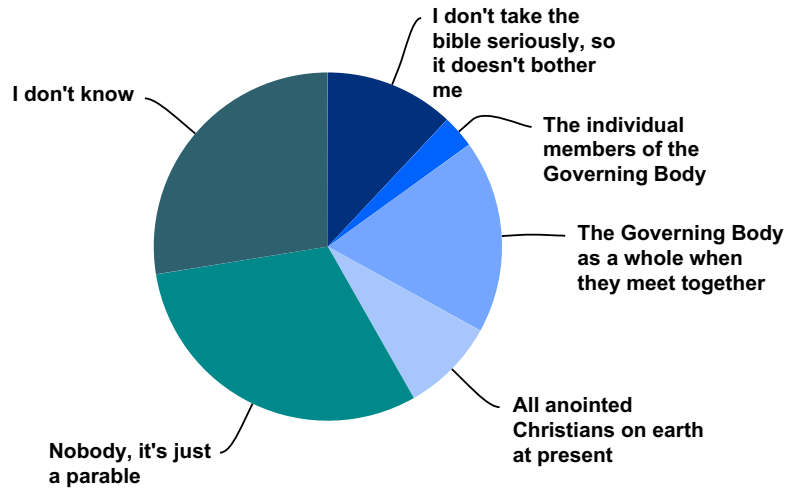

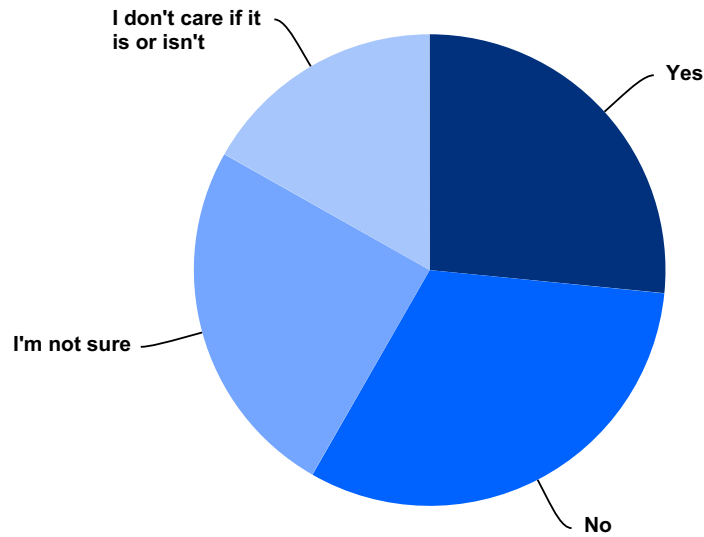

Q48 Do you believe that Jehovah's Witnesses represent God's spirit-directed organization?

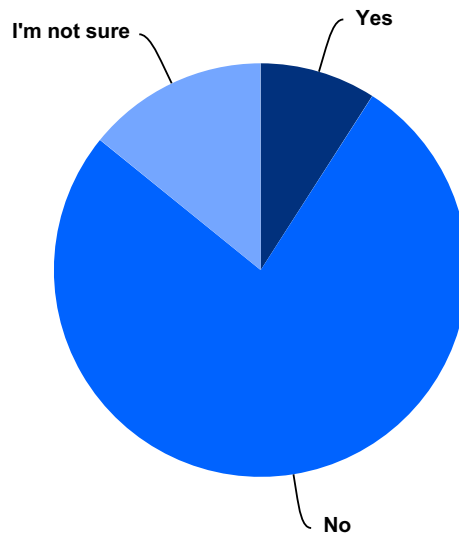

Q49 Do you believe that congregation elders are appointed by holy spirit?

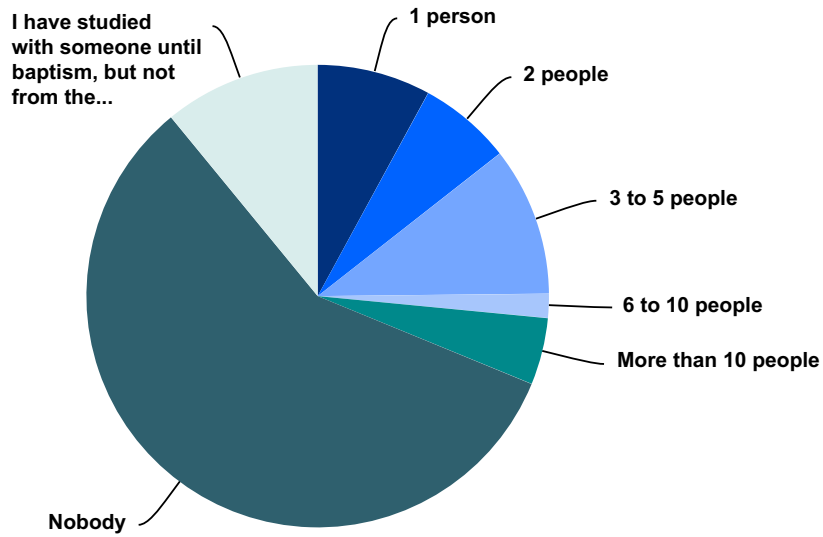

Q50 During your years as a Witness, how many people have you personally assisted from first contact on the ministry to baptism?

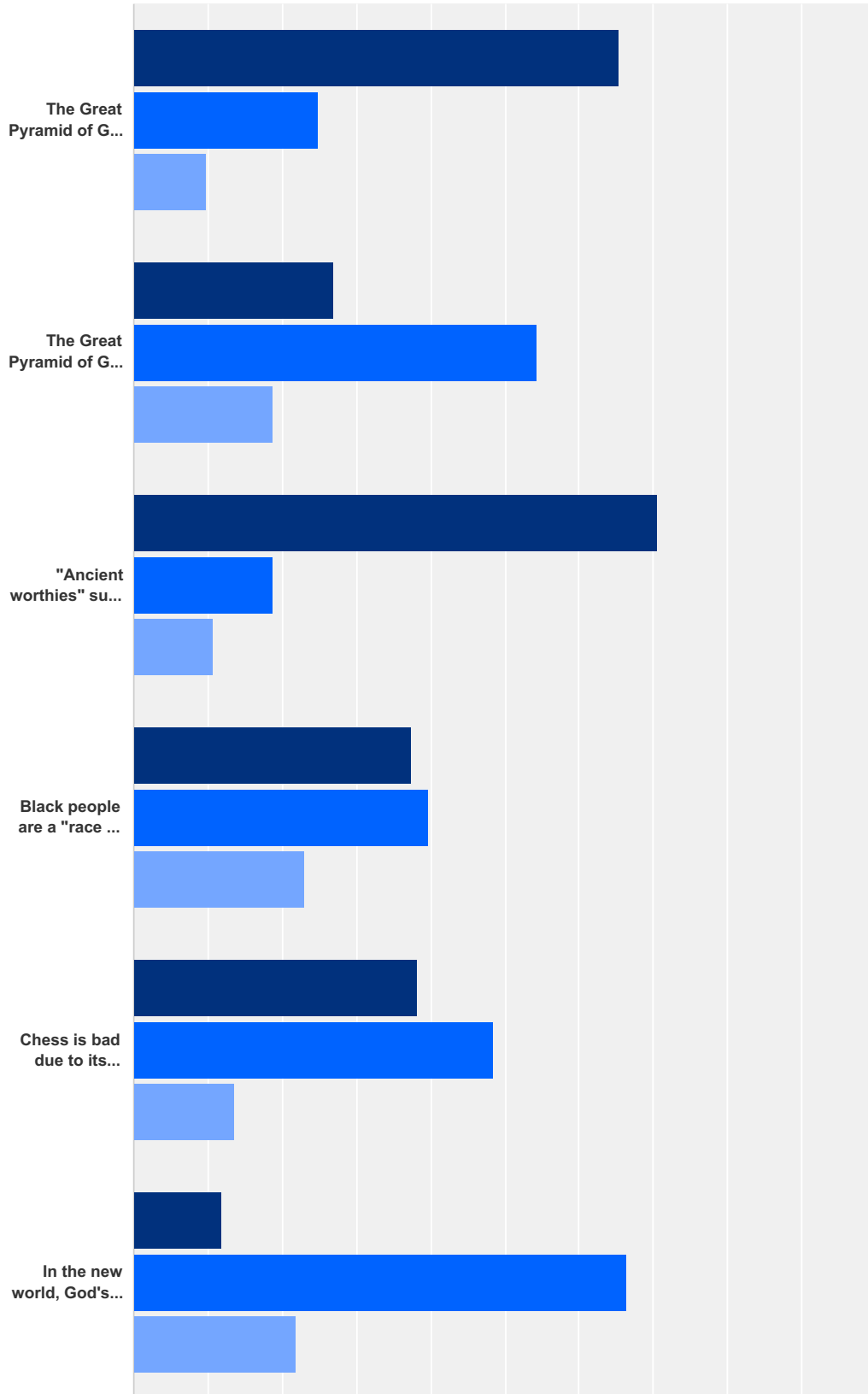

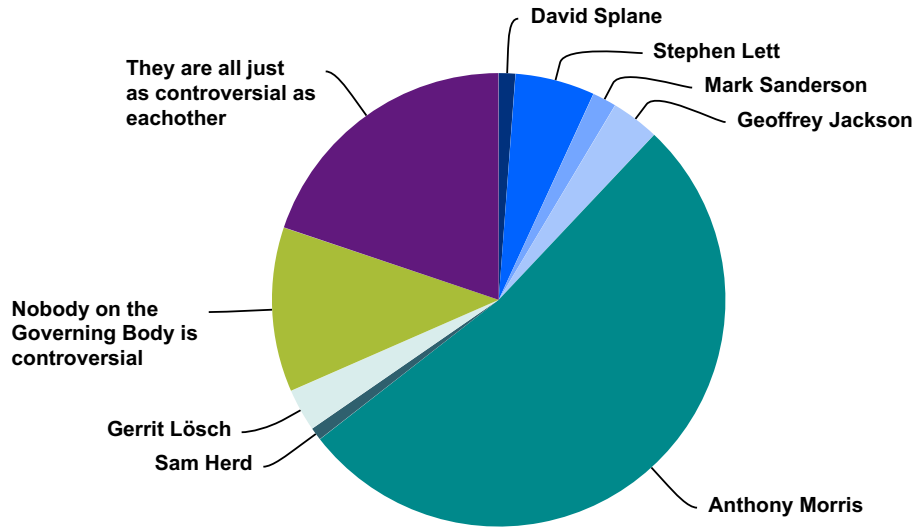

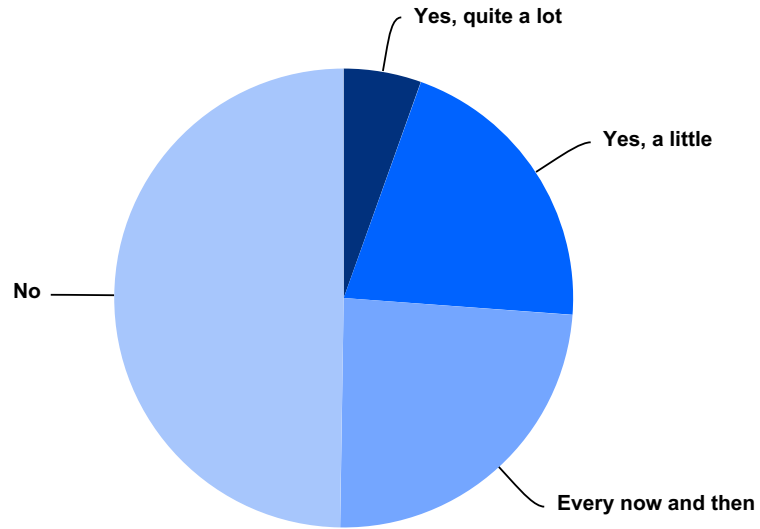

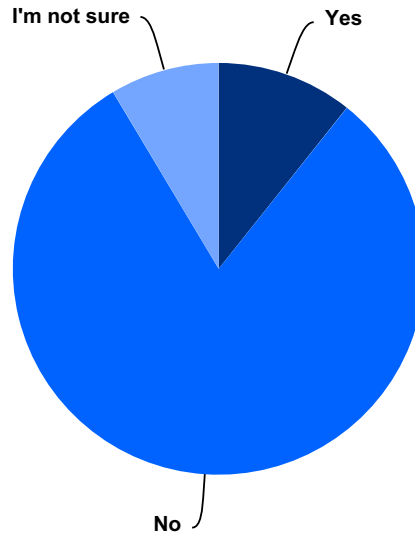

Q57 If you answered positively to the previous question, are you comfortable with your donations being used to help pay for legal costs and damages in child sex abuse cases?

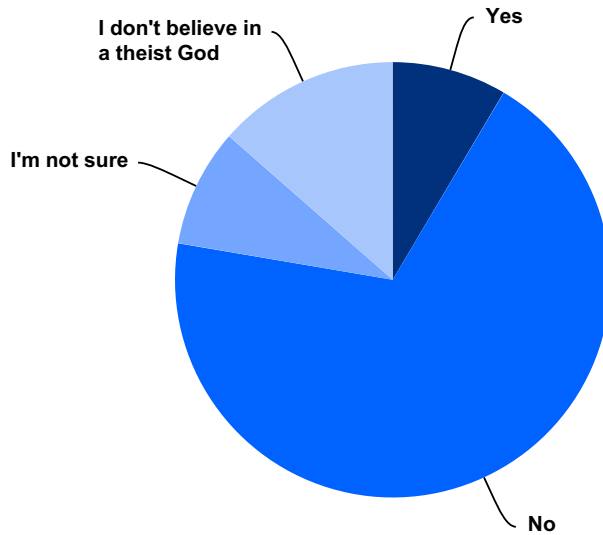

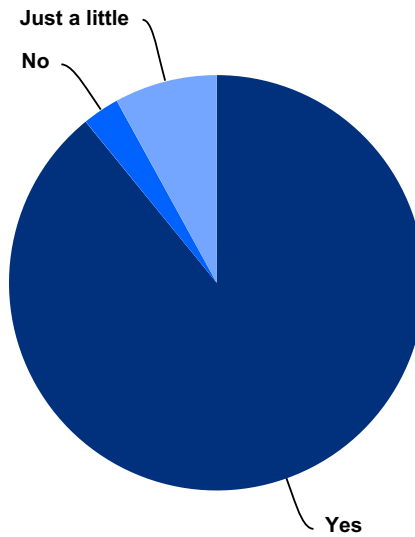

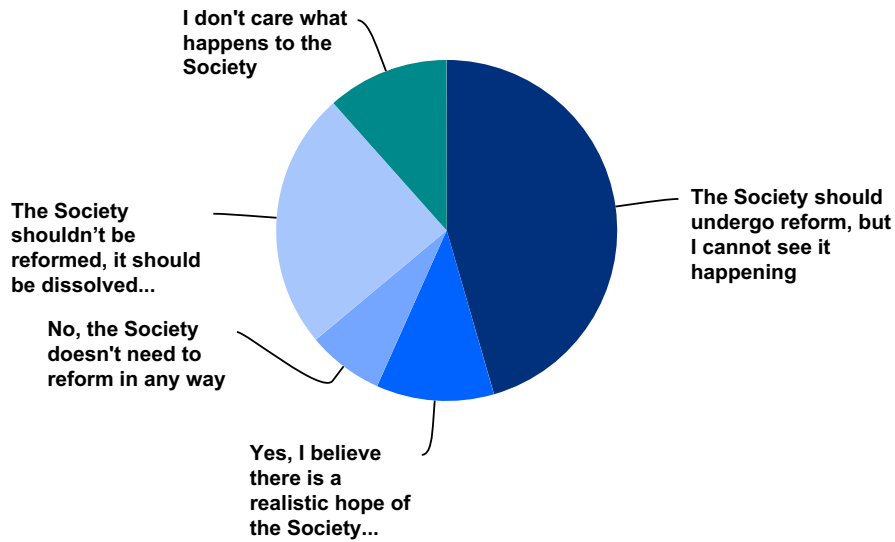

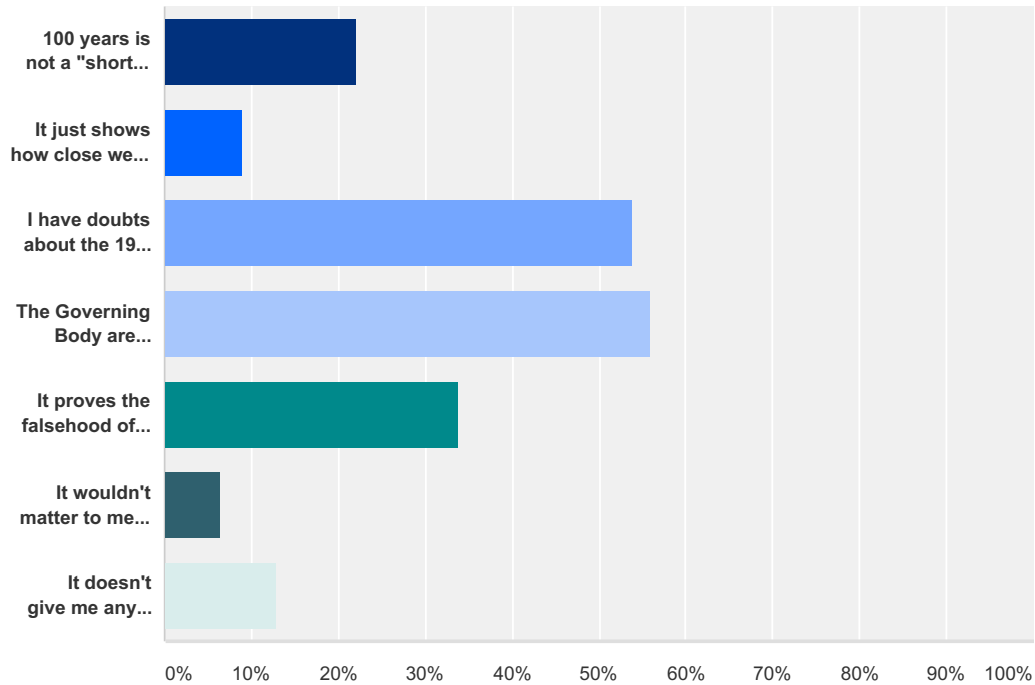

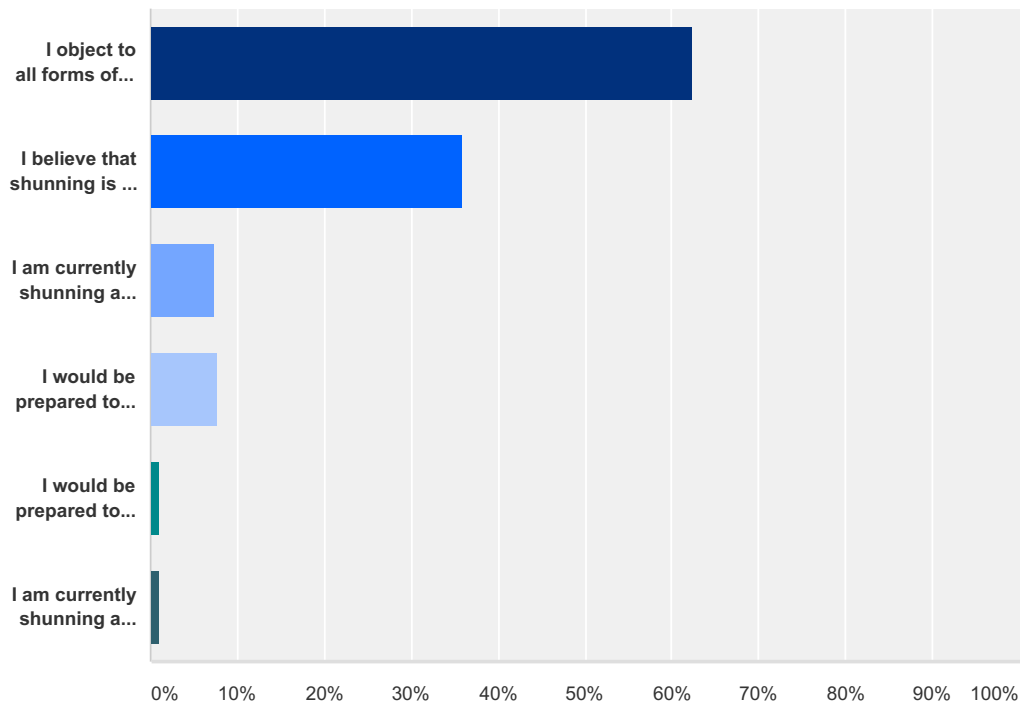

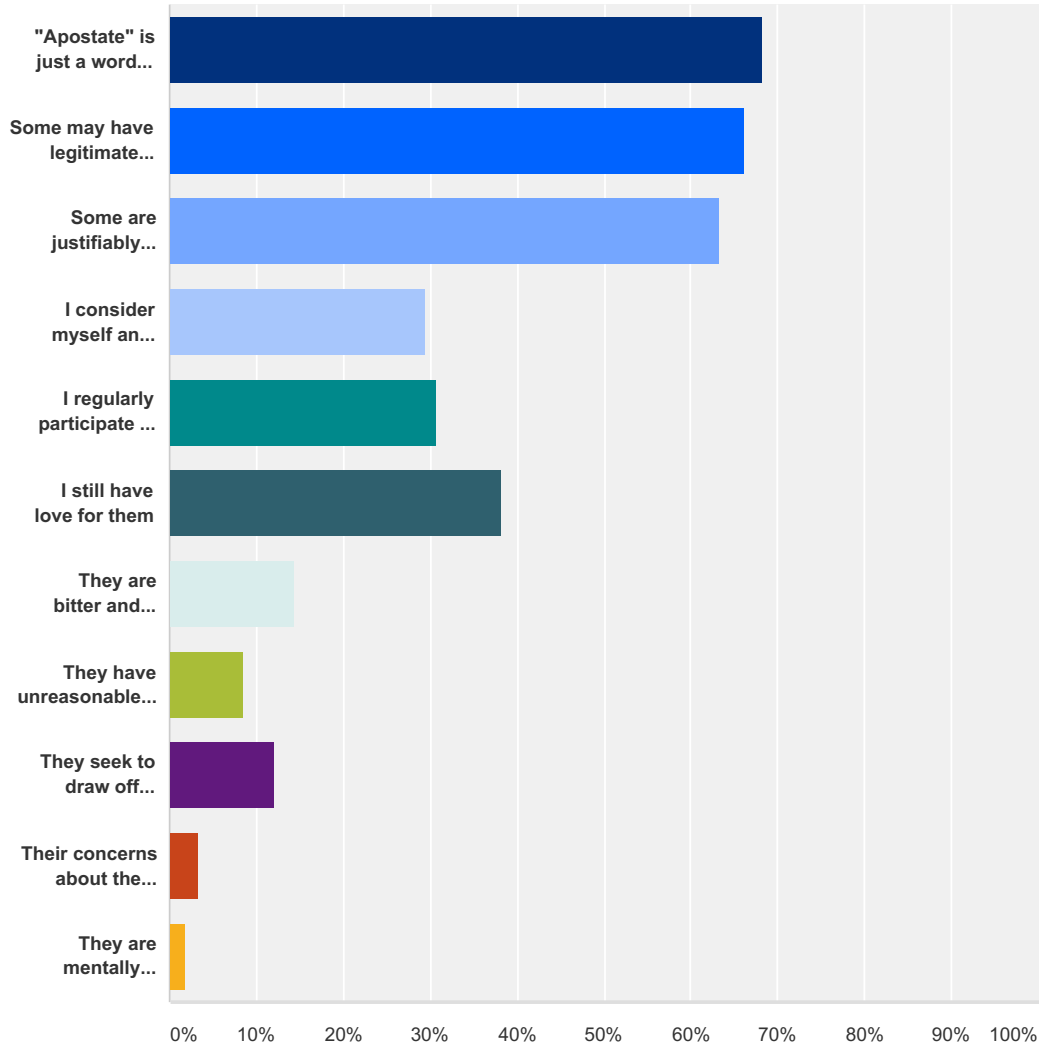

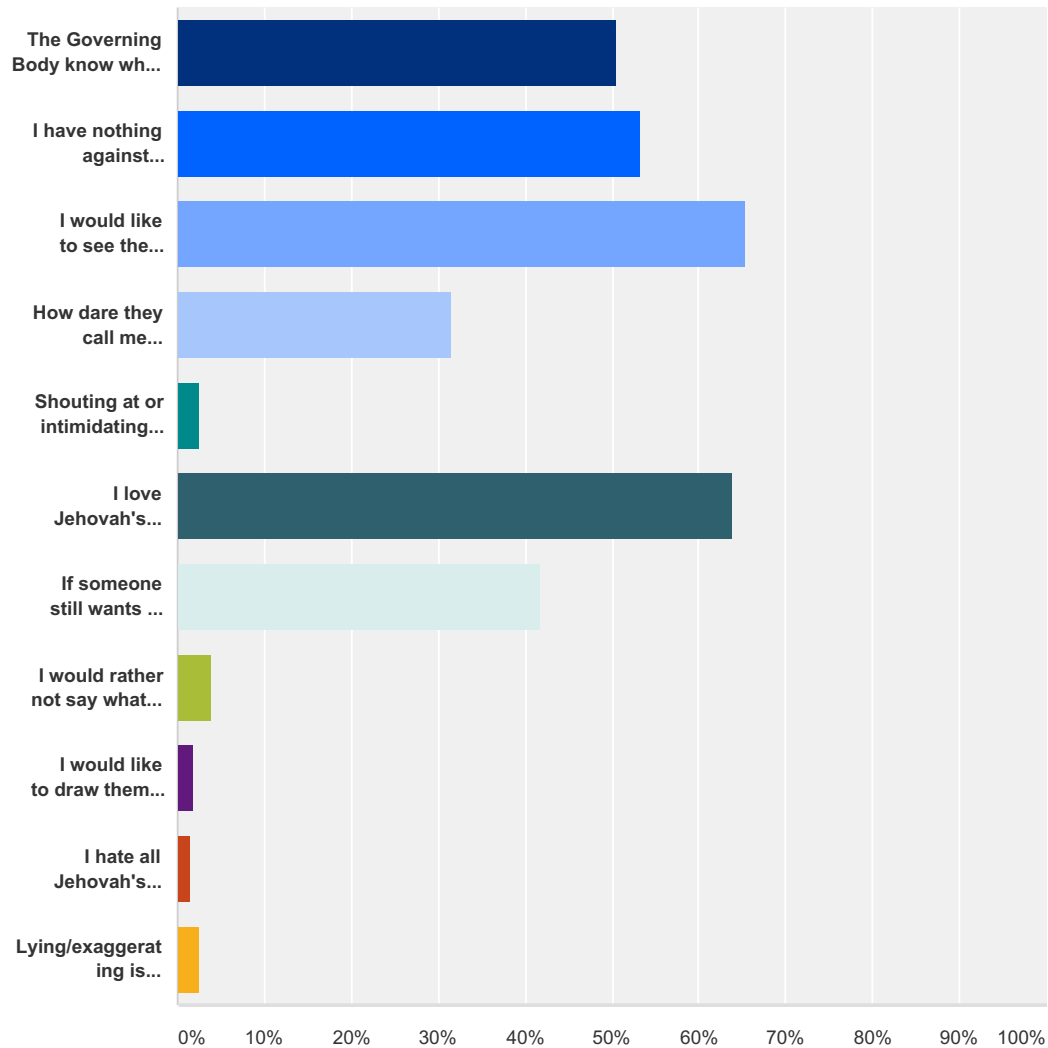

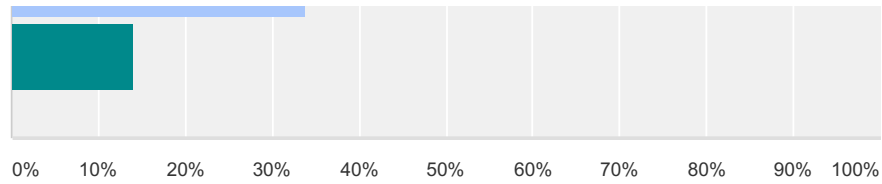
Q68 If you consider yourself as having awoken from Jehovah's Witness indoctrination, what resources would you say were most influential in your awakening?

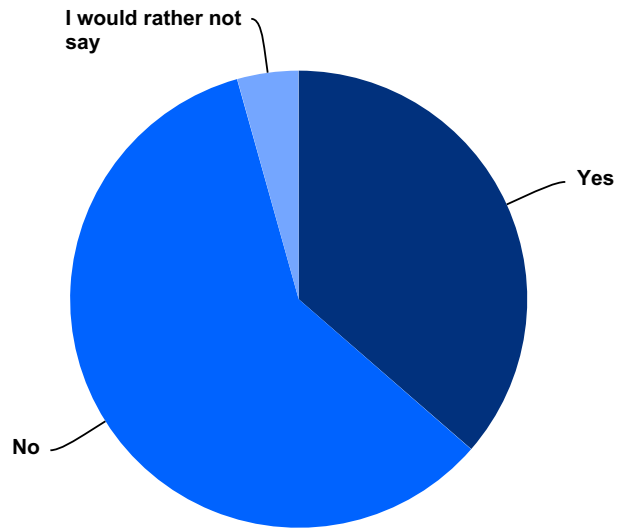

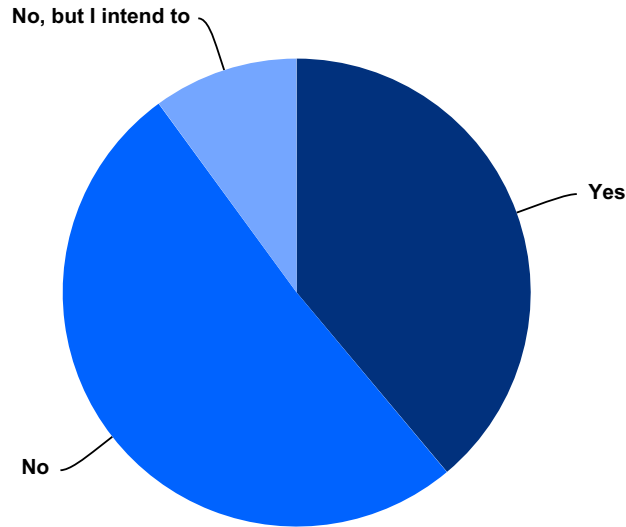

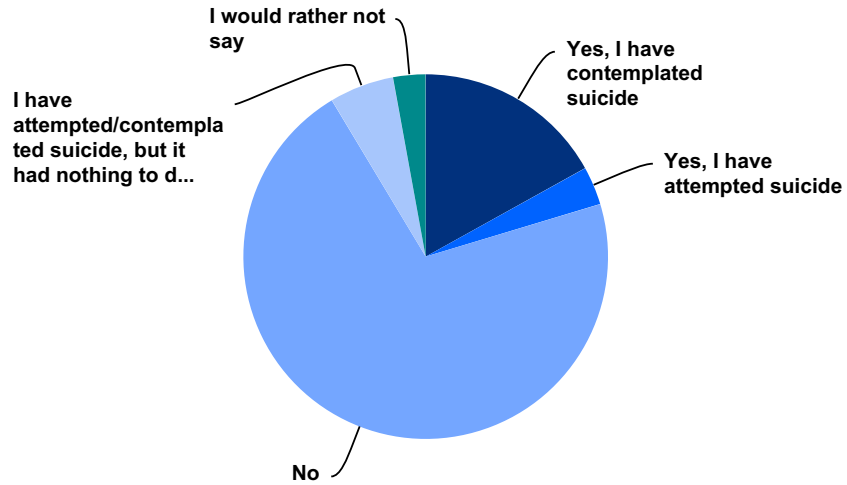

Q74 Have you ever contemplated or attempted suicide as a result of your Jehovah's Witness beliefs, or the prospect of shunning?

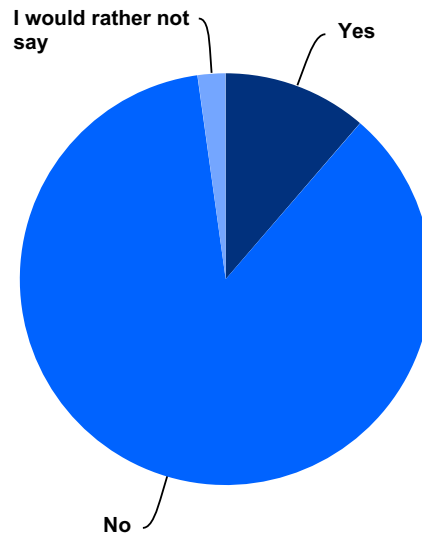

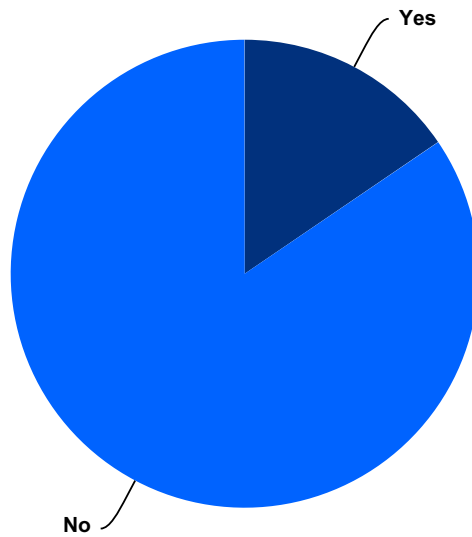

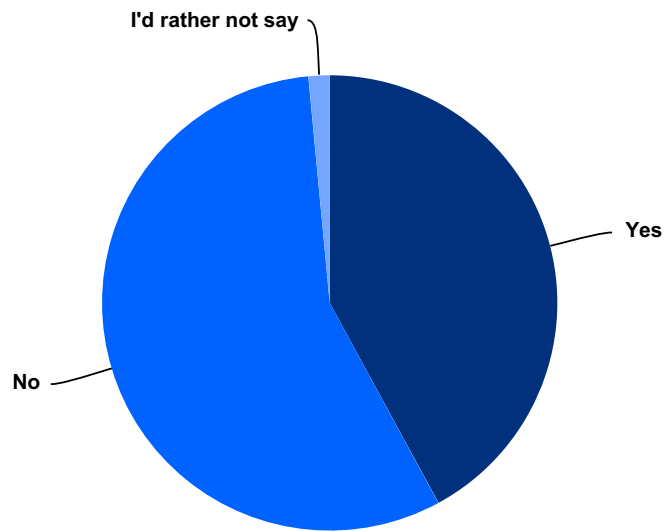

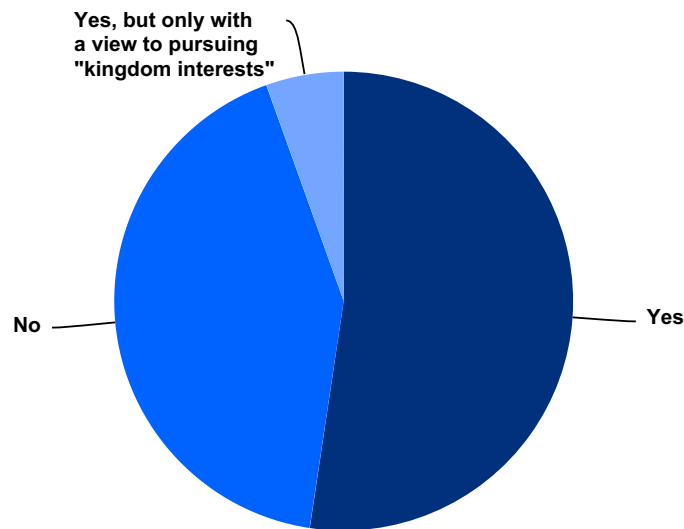

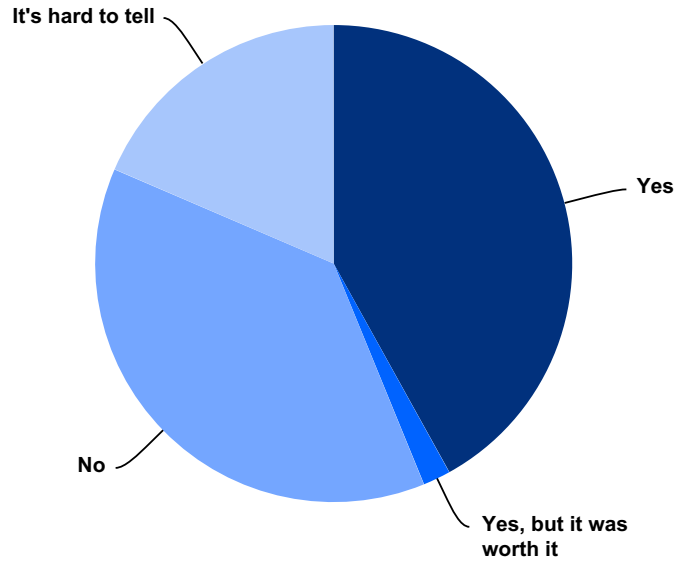

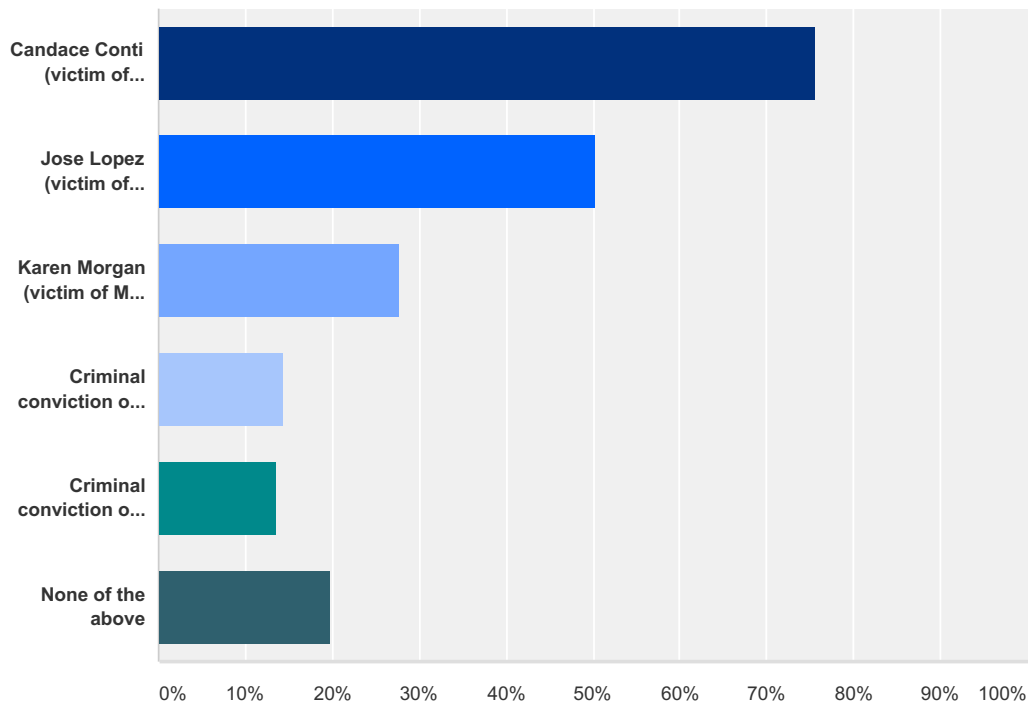

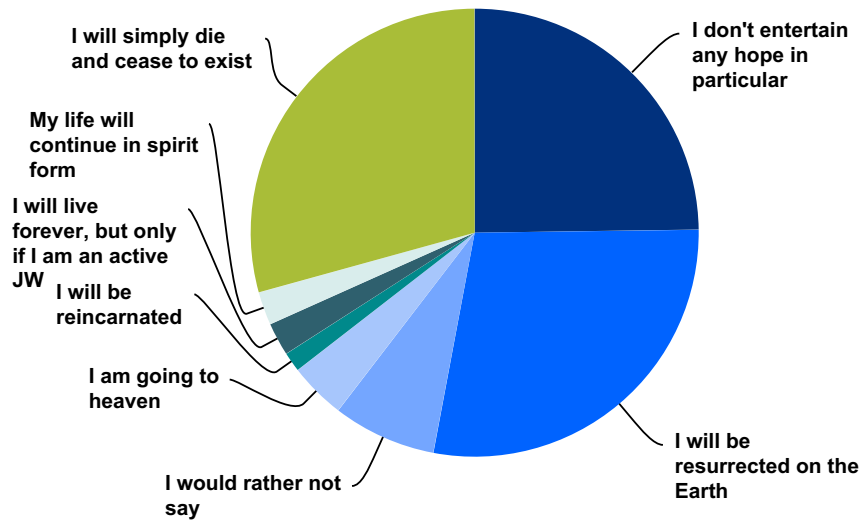
