FELONY INFORMATION

COUNT ONE

Comes now Holly L. Meyer, Prosecuting Attorney for the 16th Judicial District of Arkansas, of which Cleburne County is a part, by the authority and on behalf of the State of Arkansas upon information accuses the defendant or an accomplice of committing the offense of **SEXUAL ASSAULT IN THE SECOND DEGREE**, Arkansas Code Annotated **5-14-125(a)(4)(A)(iv)(b)(1)**, a **Class B FELONY**, on or about **OCTOBER 2017**, a person commits sexual assault in the second degree if the person engages in sexual contact with a minor and the actor is the minor's guardian, an employee in the minor's school or school district, a temporary caretaker, or a person in a position of trust or authority over the minor, to wit: *eleven year old minor A.E.*; sexual assault in the second degree is a Class B Felony, against the peace and dignity of the State of Arkansas.

COUNT TWO

Comes now Holly L. Meyer, Prosecuting Attorney for the 16th Judicial District of Arkansas, of which Cleburne County is a part, by the authority and on behalf of the State of Arkansas upon information accuses the defendant or an accomplice of committing the offense of **SEXUAL ASSAULT IN THE SECOND DEGREE**, Arkansas Code Annotated **5-14-125(a)(4)(A)(iv)(b)(1)**, a **Class B FELONY**, on or about **2010**, a person commits sexual assault in the second degree if the person engages in sexual contact with a minor and the actor is the minor's guardian, an employee in the minor's school or school district, a temporary caretaker, or a person in a position of trust or authority over the minor, to wit: *seven year old minor R.J.*; sexual assault in the second degree is a Class B Felony, against the peace and dignity of the State of Arkansas.


COUNT THREE

Comes now Holly L. Meyer, Prosecuting Attorney for the 16th Judicial District of Arkansas, of which Cleburne County is a part, by the authority and on behalf of the State of Arkansas upon information accuses the defendant or an accomplice of committing the offense of **SEXUAL ASSAULT IN THE SECOND DEGREE**, Arkansas Code Annotated **5-14-125(a)(4)(A)(iv)(b)(1)**, a **Class B FELONY**, on or about **2010**, a person commits sexual assault in the second degree if the person engages in sexual contact with a minor and the actor is the minor's guardian, an employee in the minor's school or school district, a temporary caretaker, or a person in a position of trust or authority over the minor, to wit: *nine year old minor K.O.*; sexual assault in the second degree is a Class B Felony, against the peace and dignity of the State of Arkansas.

COUNT FOUR

Comes now Holly L. Meyer, Prosecuting Attorney for the 16th Judicial District of Arkansas, of which Cleburne County is a part, by the authority and on behalf of the State of Arkansas upon information accuses the defendant or an accomplice of committing the offense of **SEXUAL ASSAULT IN THE SECOND DEGREE**, Arkansas Code Annotated **5-14-125(a)(4)(A)(iv)(b)(1)**, a **Class B FELONY**, on or about **2011**, a person commits sexual assault in the second degree if the person engages in sexual contact with a minor and the actor is the minor's guardian, an employee in the minor's school or school district, a temporary caretaker, or a person in a position of trust or authority over the minor, to wit: *sixteen year old minor Z.T.*; sexual assault in the second degree is a Class B Felony, against the peace and dignity of the State of Arkansas.
